### Wastecorp® Mud-Sucker Warranty

Wastecorp® Pumps/ WPCI Environmental Brands is designated "SELLER" and warrants each new Mud-Sucker Diaphragm Pump Product manufactured and sold by them.

### Standard Product Warranty

Wastecorp® Pumps/ WPCI Environmental Brands (hereinafter "Seller") warrants for a period of one (1) year from the date of initial operation but not more than eighteen months from the date of shipment ("the warranty period"), that the product manufactured and sold hereunder will be free from defects in material and workmanship. Seller does not warrant product accessories such as engines, motors, gauges, electrical control equipment or other items not manufactured by the Seller. Accessories are subject to warranties as given by their respective manufacturer Seller's obligation to this warranty which Seller's examination shall disclose to its satisfaction to have been defective. Purchaser shall assume all responsibility and expense for removal, installation and freight. Repaired or replaced parts/pump under this warranty will be covered for the Warranty Period only.

### To Secure Wastecorp Warranty Service: **SAVE YOUR SALES SLIP OR INVOICE**

To secure warranty service the purchaser must: (A) report the defect to Wastecorp within the applicable warranty term. (B) Present evidence of the warranty start date and (C) make the product available to Wastecorp or its authorized local representative/dealer service center within a reasonable period of time.

(c) has been used in manner contrary to Seller's printed instructions. (D) Depreciation or damage caused by normal wear, lack of reasonable and proper maintenance, failure to follow operating instructions or lack of proper protection during storage. (E) Normal maintenance parts and service.
